## Heritage Fund at Navarino

Leave a legacy for future generations to enjoy the wonders of nature at Navarino Nature Center.

The Heritage Fund consists of several fund classifications which donors / benefactors can designate funds into. The funds will include: Education, Real Estate, Capital Expenses and Board of Directors Discretion. Each fund has a specific purpose, and funds from one account cannot be comingled or shared with another account.

Donors can designate where their funds are to be retained. Funds that are not designated will be evenly divided between all funding accounts.



# Heritage Fund Categories:

Each category has an intended designation and must be used for those intended purposes.

## Education:

This fund will assist in supporting educational activities at Navarino Nature Center (NNC). Funds from this account are to be used for instructional materials, props, papers, books and continuing education. All funds assist in educational areas — toddler, school-aged, public or senior programming.

## Real Estate:

Funds from this account will be used to maintain, construct and acquire property on the behalf of NNC. Property is intended to include, but not limited to, real property, buildings and building maintenance on the property.

## Capital Expenses:

This fund will be used for the purchase and maintenance of mobile equipment on the property. The intent of this fund is not for annual or periodic scheduled and budgeted repairs, but for unusual and unexpected major expenses. Examples: mower, UTV / Gator, tractor, trolley and wagons.



## Board of Directors

### Discretion:

This fund will be used for the Board of Directors to fund whatever is not covered by other designated accounts that they determine to be beneficial to the nature center.
